Thanks for your feedback and discussion this afternoon. Attached you will find the presentation from this afternoon's call.

I noted action items below – please let me know if something is incorrectly noted or if there is something missing.

Timeline – December 11th, 2020 Wildfire Governance Steering Committee

Action items:

1. Break down the 10-year historical weather model into CPZ-level (circuit segment) analysis to more accurately compare PSPS frequency to the Risk model.
2. Break down actual 2019/2020 events into CPZ-level
3. Overlay Risk model to the PSPS model and actual events at the CPZ-level.
 - a. Include if any circuits have been hit by recent wildfires and if they are currently in rebuild plan
 - b. Look at actual PSPS events with >5 across 2019 and 2020
4. Incorporate Tx into the analysis
5. Deep dive into the drivers behind each model – Risk and 10-year PSPS – to help explain the differences in the results.
6. [REDACTED] to connect with KPMG and [REDACTED] to complete this analysis and examine a potential framework for [REDACTED] approval.
7. Renata to setup a follow-up meeting prior to Dec. 11th.

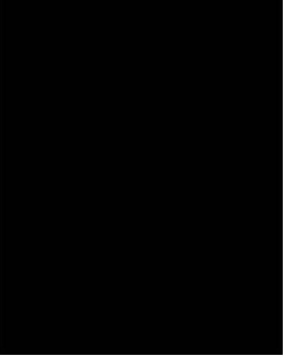

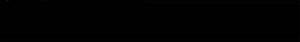
