Below are the notes I received from today's field scoping meeting:

[REDACTED] Keswick 1101: Move forward with the Preferred scope except continue OH from LR 1586 all the way to SAP ID [REDACTED] with 1/0ACSR TW. Harden tap off of fuse 2407 with 1/0ACSR TW.

[REDACTED] Konocti 1101: Replace in place. Note on updated key sketch that the conductor between LR 95078 to fuse 6561 will already be replaced with 3-397AI TW under PM# [REDACTED]. We will move forward with replacing in place.

[REDACTED] Upper Lake 1101: Remove the "ECOP" from EDRS 2020-82007 title. We will move forward with remote grid option and installing TW between the substation and 472084.

[REDACTED] Bucks Creek 1101: There is a chance we may move forward with ALL UG proposal. Customer at Loc F may be relocated (need to talk to Railroad services) to confirm since Remote Grid does not seem like an option. On hold until we can decide whether or not to move forward with ALL UG.

For the projects listed above, the field scoping documents have not been returned to us, but this is something we can start on.

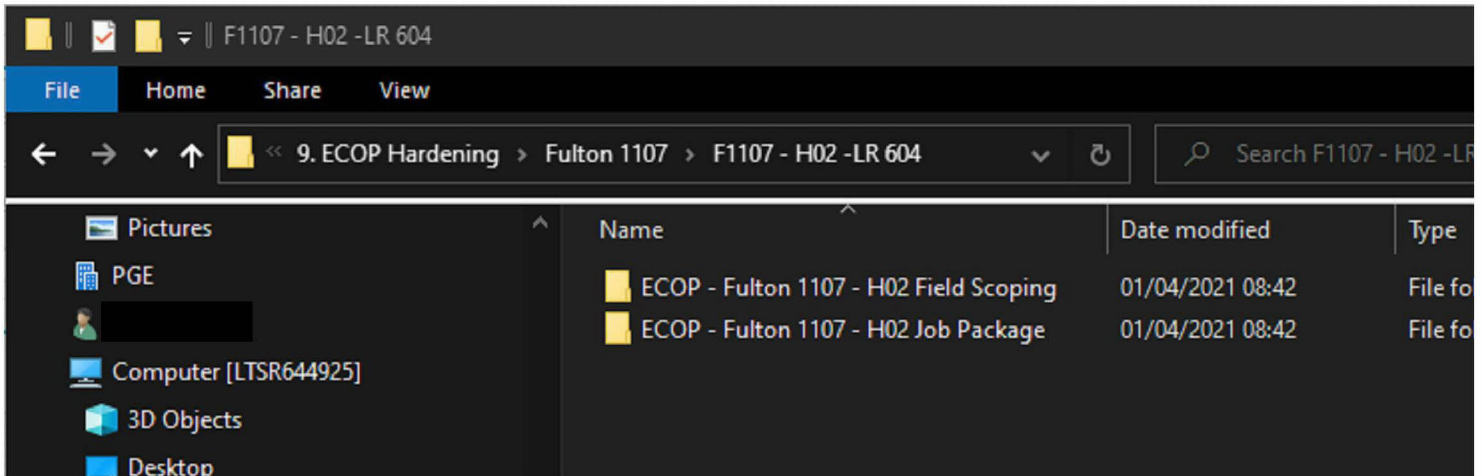

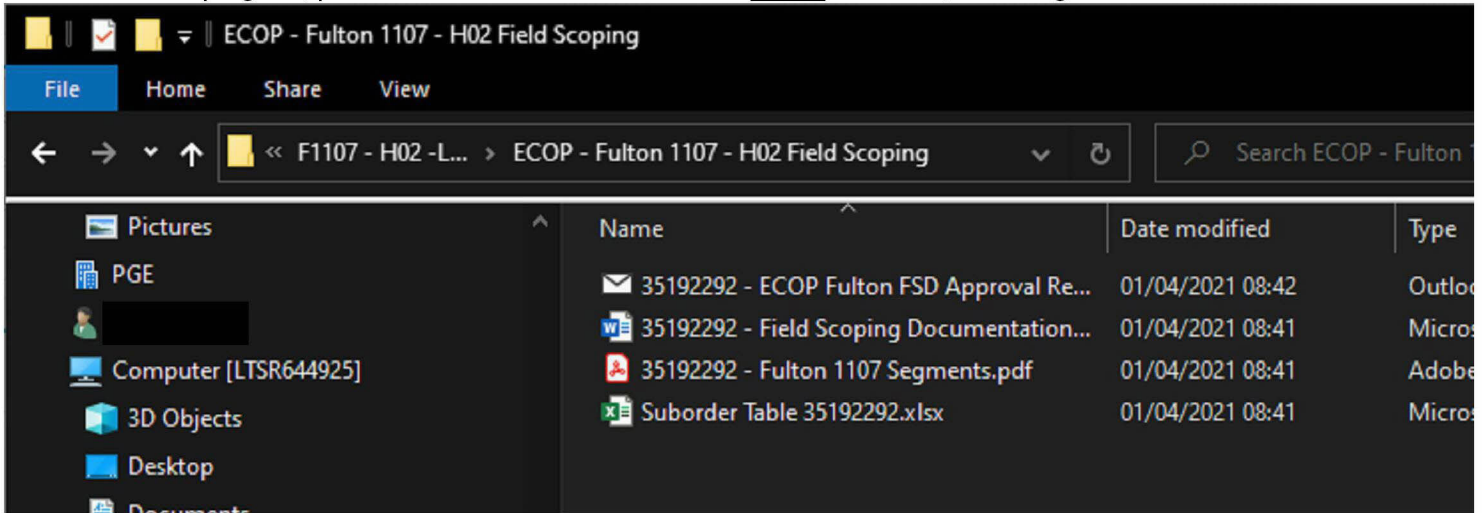
