- Upper Lake – The preferred alternative was Remote Grid which wasn't really accounted for in the template EASOP so I had to make some stuff up.
- Konocti – The preferred option (ALL OH) came out to cost more than the hybrid. The hybrid for some reason had an overall shorter distance so despite being partially UG, it was less than the OH option. I don't know why the preferred option was ALL OH. Maybe it's due to other constraints but I couldn't find anything in the FSD or another other documents that said why.

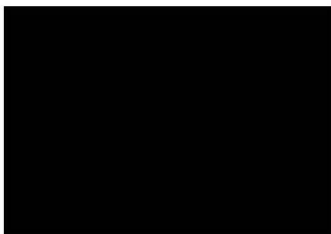

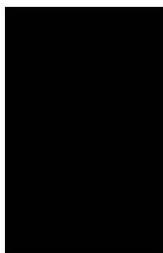
