Sorry for the delay. I thought I had sent this out earlier today but I just realized I never did.

A note about the other two phases of Middletown 1103 LR 830 (Phase 3 & 4). I went ahead and updated EDRS for both of them despite Phase 3 having some pending changes to the KS and Worksheet. But those changes won't impact the WFRG or EASOP, so you can go over those with the WFGC and just remember that the preferred is all UG.

The other thing is we need a decision on Columbia Hill. It turns out that it is for TripSaver 8233 zone, which was ranked higher about 600 on the previous model but is ranked ~2000 on the latest model. We suspect it was still on the list as it may have accidentally been re-named to zone LR 2212 which is 606 on the new priority model. It is not in the top 20% so we need to decide if we should cancel it or keep moving forward with it.


