Similar to previous years, we need to identify projects outside of 08W that will be designed and constructed to hardening standard (Capacity, WRO, NB, etc.). We need to do this for two reasons:

1. The Wildfire Safety Division (WSD) of the CPUC has formally requested we identify all hardening work regardless of MAT
2. The System Hardening program overall requires all hardened miles captured to reflect accurate internal and external reporting metrics

I need your guidance on how to best gather this initial data:

- Do we request the Estimating team to review their entire portfolio and provide their findings? Or
- Run a systematic Tier 2/3 WHIP cloud analysis from GIS as a starting point and then have Estimating confirm hardening scope?
