Yes, during the Wednesday directors call he wanted to see a 1 week projection of the different status groups in the WSHP summary we produce. I've been working on his request this weekend to figure out what is needed to get him the information so its refreshable each week. A few snags were found however, due to some of the SQL data that feeds our summary does not have all of the date columns needed. As such I've reached out to the WTA team to help bring the necessary information into the SQL table.

The analysis I'm doing in the mean time is external to the WSHP summary file and will need to be hard coded into the summary for the time being. I expect this to be readied by Monday in advance of the Wednesday call.

Below is an initial view of the table. Based on my current projections there isn't going to much movement within the next week moving from ESTS to PEND to USNC. There is however 3.7 miles expected for the week of 3/14/21 based on feedback from the construction team.
