

2021 work plan requirements-

- 1. 200 miles in estimating by end of January for new nominations **Update needed**
- 2. 200 miles out of estimating by end of 3-31-2021. only if millstone one is met and this is still being reviewed after the team receives the work.
- 3. Construction to execute 300 miles, including fire rebuild and line removal in 2021
- 4. 300 additional miles out of estimating by the end of Q3 2021- Minimum needed is a quarters worth of work in front of construction at all time after they have a quarter in hand. (Roughly 120 miles)
- 5. 200 additional miles estimated by end of 2021 for a total of 700 miles estimated in 2021.-Stretch target
- 6. 2021-2023 requirment >1100 miles total including 10% OH to UG/ line removal.
