Sorry I couldn't get to this sooner. I'm not sure that I'll have much time to prep for this meeting but I do need some clarification on your request.

1. What type of input on agencies would you like? – See highlight below.
2. I don't know which projects were elevated due to PSS review. [REDACTED] might.
3. What do you mean by “consistent set of agencies” – see highlight below.
  - a. I definitely won't have information on projects that haven't been approved by the committee
  - b. We may not yet know what agencies are going to be involved with some of the projects within the zones you provided. These zones represent about 120 miles with should be represented by 60+ orders. Once we identify those orders we may want to pull in [REDACTED] to help us identify the agencies early.
