Is the 2021 Work Plan Ready for Execution?

- Yes, the work plan is ready and execution should move forward with the jobs asap
- The only MP&P program that is undergoing changes is System Hardening, as the plan is being revised to align with a new risk model – additional projects are expected to be identified

  - Note: 2021 MPP Approved Budget (column CX) is based on a copy of November RES, and will be updated in mid-January
