Plumas National Forest and the Railroad will meet up with the PG&E group at the Rock Creek Power House at 9am.

PG&E will have a safety tailboard, condense vehicles as much as possible in Chico then drive to the Rock Creek Power House, approximately 45 minutes away to meet with the rest of the team. There is no cell reception there so if there are any changes to this plan we will need to be coordinated a day prior.

The intent of the visit is to have open and professional discussions on how all parties involved on System Hardening projects can collaborate to meet everyone's needs and expectations.

Also, please find below PG&E's Covid Safety Protocols for this meeting:

The Centers for Disease Control and Prevention (CDC) now recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain, and especially in areas of significant community-based transmission. To align with this direction, PG&E is now requiring employees and non-employee workers who must leave their home to work during the COVID-19 pandemic to wear face coverings when:

- *In contact with customer, while continuing to maintain at least a six-foot distance per social distancing guidelines;*
- *Working on a job site in the field; or*
- *Working at a PG&E Facility in the vicinity of other people.*

For those who have difficulty achieving a good seal, using a mask with straps that wrap around the head, instead of just the ears, may be helpful. Beards may also interfere with achieving a good seal and it is recommended that those with beards make sure there are no gaps and the mask is hugging your skin.
