- 3. In Columns I and K labeled "UG" and "OH" respectively you will find the breakdown between underground and overhead mileage associated with each order

Note that the report does not roll up to the "Planning Order" level thus you will need convert to PM orders to get what you need in your question below. Furthermore the "Summary data" tab is a direct pull from a DOT report labeled "WSHP Project Log".

This data is readily available for analytics within the DOT and can also be pulled from EDS SQL servers if needed.
