Just a quick reminder for tomorrow morning when traveling up Highway 70 (and on all future travels to this location):

1. READ the travel plan, complete your driving JSA, conduct your 360 walk-around, use the LiveSafe App and ensure your supervisor is aware of your travel plans.
2. ESNURE your vehicle is TD-1464-compliant.
3. CHECK weather conditions in the morning before your leave.
4. BE CAUTIOUS when driving up/down Highway 70. A few noteworthy tailboard items:
 - Beautiful views can be a distraction, keep your eye on the road. 😊
 - Watch out for sharp curves, blind spots, rocks and boulders.
 - Turn your lights on especially when driving through the tunnels.
 - Maintain an appropriately low speed when navigating around bends.
 - Watch out for the public or third party drivers—they have been known to drive fast, take selfies, cut corners etc.
 - Expect road construction and traffic stops along the highway. Each stop can take 10-15 minutes of wait time.
 - Bring lunch, snacks and water for yourself. No restaurants or gas stations in the vicinity.

If you are unable to meet us by 0815 due to traffic delays or other unanticipated circumstances, you may drive directly to Bucks Creek powerhouse. Check in at the Outage trailer to ensure you are appropriately tail-boarded before entering the powerhouse. Read the parking instructions carefully and avoid backing, if possible.
