Multiple sources are reporting that a wildfire, dubbed the Dixie Fire, is burning in the area of Pulga Rd and Dixie Rd. The fire has grown to 500 acres in size and is zero percent contained. Evacuation warnings have been issued for the Pulga and East Concow areas. There were no details regarding injuries, evacuation orders, or major roadway closures. Anticipate localized disruptions as firefighters respond.

Winds in the area are blowing from the south at five miles per hour and relative humidity is at 50 percent.
