A fire broke out before 8 a.m. Wednesday near Bald Mountain Helitack Base east of Long Barn.

The fire was holding at an estimated 5 acres burned about 9:40 a.m., Stanislaus National Forest staff posted to social media, with images from a **Pacific Gas and Electric Co. webcam** in Strawberry.

Jason Kuiken, the forest supervisor, confirmed the fire in a brief phone interview.

Sarah LaPlante, the ranger overseeing the forest's Mi-Wok and Summit districts, said she was seeking more information on the fire.

Asked whether Columbia Air Attack was assisting the Forest Service with the fire, Cal Fire Tuolumne-Calaveras Unit staff referred questions to the Forest Service.
