Mr. Sommer,

Thank you for your note. Any additional information you may have as to how the Sequestration will affect the LOE would be very useful, particularly if there are any firm dates by which you would need the devices shipped in order for you and other government folks to be able to travel to theater.

Regarding the status of our shipment, please see below for an update I sent to Major Murphy earlier this morning. This should provide some insight into what is driving our shipment timelines as we work toward finalizing an exact date:

*As per our previous discussions, the 4s devices we are shipping have been specially built for the purposes of our LOE. In so doing we have had to revalidate and retest every aspect of the device configuration to ensure that these systems meet our standards and expectations. We have significantly accelerated Theranos' previously planned release of 4s in order to meet our objectives for this program. Further, we have added additional features to our user interface capabilities following our VTC session with Major Nelson, and we have been incorporating newly received information from LTC Romero to ensure that the device is able to operate under the IT and security requirements of the network in theater. These processes have guided our delivery timelines; we have been allocating all the resources we can to this project in parallel with our company's commercial launch. As a rapidly growing company we are managing these timelines as best as possible while making sure that the integrity of our products and program goals are not compromised.*

Please let me know if you have any questions on the above, and we can set up a telecon to discuss this further. I am available to connect on any of the above in detail this week if it would be of value.
