Fosun Group is a Shanghai-based conglomerate investing all over the map, particularly focused on introducing advanced Western technologies into the Chinese markets that will directly benefit the rising middle class. They are looking at media, luxury, food & beverage, healthcare, biotech, etc., with particular interest in big-name brands or acquisitions that will boost Fosun's brand equity in the west. As an anecdote — a rival bought PizzaExpress, the largest European pizza chain, prompting Fosun to immediately investigate whether they could acquire Burger King. In the last 6 months, Fosun has bought a luxury womenswear brand, a Hollywood studio, a Portuguese insurer, part of a German bank, and Club Med — the French luxury hotel.

Fosun's minimum investment is 100 million. They traditionally take stakes between 10-30%, unless they acquire a company outright. They would be a passive investor, primarily interested in taking Theranos' tech to China in a big way. Fosun is among the most connected Chinese corporate empires with properties across the spectrum (real estate, pharma, retail, etc.)

We believe Fosun could be very interested in the cutting edge medical tech. owned by Theranos, and hope to pitch the idea on August 4th (Jing is in Shanghai at the moment). We want to make sure that Theranos could be at all interested in such an investment. While we can't promise anything, we suspect an investment, if made, would dramatically boost valuation and provide a ton of capital for Theranos to grow internationally (ahead of schedule). I believe our last call with Sunny left off with Theranos needing little to no help fundraising and with only long-term international ambitions. I recognize this dynamic. We just believe the Fosun opportunity may be too good to pass up.
