FIFTH AMENDMENT TO THE CONSULTING AGREEMENT

"In consideration for Services provided, Company shall pay Consultant (a) an hourly rate of One Hundred Sixty and 00/100 Dollars (\$160.00). Notwithstanding the foregoing, Consultant shall obtain prior written approval from Company (i) before working more than one hundred seventy-three hours in any given month while this Agreement is in effect; and/or (ii) in the event Consultant's total compensation is set to exceed One Hundred Ten Thousand and 00/100 Dollars (\$110,000.00) during the term of this Agreement. Consultant's monthly compensation payment, if undisputed, shall
