Suspicious Order Reporting

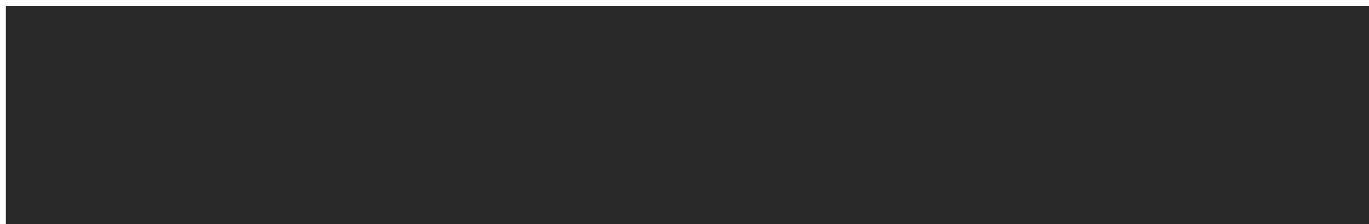
WALGREENS reported on a monthly basis to the Detroit DO; however, since 1/1/12, no reports have been received at the Detroit DO.

7. The Detroit Field Office is aware of the increase of DEA 222 Order Forms that have been provided by the WALGREENS DC located in Perrysburg, Ohio. The increase may be due to the suspension of the Jupiter, Florida DC registration and the WALGREENS in Perrysburg has gained some of their customers. In a cursory review of the order forms submitted by WALGREENS, there does not appear to be any customers from the Florida area.

8. A prior request was made by WALGREENS Perrysburg DC for an exemption of 21 CFR 1305.13(b), regarding the procedure for filling DEA 222s, which was denied in May of 2009. Additionally, a Letter of Admonition was given to the WALGREENS Perrysburg DC, stating violations regarding 21 CFR 1305.13(b), in June 2009.
